There will be a **mandatory** pre-bid job walk on Tuesday, November 9th, 2021 at 11:00am starting at McCabe Union Elementary School, 701 West McCabe Road, El Centro, CA 92243. Bidders are to meet at: McCabe Elementary Main Office. No bidders will be accepted upon arrival after 10:00am. All work is proposed to begin after January 1st, 2022 and must be completed no later than June 1, 2022, with a final date to be decided at bid opening by the District. After which time the bids will be opened and publicly read aloud. All bids shall be made and presented only on the forms presented by the school district. It is sole responsibility of each bidder to ensure their bid is delivered and received in a timely manner at the location designated as specified above. *Any bids received after the time specified above or after any extensions due to material changes or project modifications shall be returned unopened. Any applicant not licensed at the time of bid opening will be rejected as non-compliant.*

Any and all Bid Documents/Specifications will be distributed at the mandatory job walk

Department of Industrial Relations Information

Bidders are advised that this contract is a public work for purposes of the California Labor Code, which requires payment of prevailing wages. These per diem rates, including holiday and overtime work, as well as employer payments for health and welfare, pension, vacation, and similar purposes, are available from the Director of the Department of Industrial Relations. Wage rates can be obtained from the Director of the Department of Industrial Relations at <http://www.dir.ca.gov/OPRL/dprevagedetermination.htm>. Pursuant to California Labor Code Sections 1720 et seq., it shall be mandatory upon the Contractor to whom the Contract is awarded, and upon any subcontractor under such Contractor, to pay not less than the said specified rates to all workers employed by them in the execution of the Contract.

As of March 1, 2015 all contractors bidding on a public works project must be registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5. <http://www.dir.ca.gov/Public-Works/PublicWorks.html>

Miscellaneous Information

Each bidder shall be a licensed contractor pursuant to the California Business and Professions Code, and be licensed to perform the work called for in the contract documents. The successful bidder must possess a valid and active Contractor's California State License (Class C-39) as previously indicated at time of bid receipt and throughout the duration of the project. The Contractor's California State License number shall be clearly stated on the bidder's proposal.

Separate Payment and Performance Bonds, each in an amount equal to 100% of the total contract amount, are required, and shall be provided to the District prior to execution of the contract and shall be in the form set forth in the contract documents. All bonds (Bid, Performance and Payment) must be issued by a California admitted surety as defined in California Code of Civil Procedure Section 995.120. Each bid must strictly conform with and be responsive to the contract documents as defined in the General Conditions.

The District reserves the right to reject any or all bids or to waive any irregularities or informalities in any bids or in the bidding process.
