McCabe's 8th grade class participates annually in AB329 for comprehensive sexual health education. Last year during the campus closure, Mrs. Wells presented to all 8th grade students. Hopefully we'll be able to do the same again this year.

5. Old Business

A parent survey was sent out for parent input for the 2021-2022 preliminary allocations categorical programs. Tutoring programs seem to be the greatest interest from our parent community. Our goal is to hit the six domains. One of the large pieces of the grant is 10% to fund the instructional aides to help provide services. A subgroup of students will be the first to receive the priority for services. A summer school program is a possibility and in the works. It will possibly be a 4-week course, Monday-Thursday for ELA, Math, a social/emotional learning (SEL) program as a recovery program. An SEL block may be a possibility with a school psychologist or counselor as well as electronic devices, transportation, and meals. If all goes well for summer school and funds are still available, tutoring will be offered based on the survey results. Mr. Phillips asked which grades we are leaning towards for summer school. That detail still hasn't been dialed in and will be based on which and how many teachers are available to teach during the programs.
