

## Interdistrict Attendance, Academic, and Behavior Contract 23-24

*This contract will remain in effect through the life of the child's interdistrict currently on file, which is every five (5) years or if there is a change in the district of residence.*

I, the parent or legal guardian of the student listed above have requested an interdistrict transfer into the McCabe Union Elementary School District (MUESD). I have read and understand the MUESD policies linked below regarding interdistrict transfers and understand MUESD reserves the right to revoke the interdistrict transfer permit if the student fails to comply with MUESD's standards, policies, and rules during his/her attendance in the District. The student's right to attendance in the District shall be revoked upon the decision of the District Superintendent or designee, providing written notice to the parent/guardian at the address in which the student was registered. All interdistrict petitions shall be reviewed every five (5) years or for the length of time the student is enrolled in the District. The determination to approve or deny an interdistrict petition will be made by the Superintendent or designee based on [Board Policy 5117](#), [Administrative Regulation 5117](#), and district enrollment patterns. Students who move to a different district will be required to apply for an initial interdistrict petition and renew with the new district every five (5) years.

Falsification of any information on the interdistrict petition is cause for immediate revocation of an interdistrict transfer approval and no further application will be considered.

Bus services are not permitted for students attending on an interdistrict petition.

**In addition to the District's regular policies, interdistrict transfer students must meet the following specific conditions:**

- **ATTENDANCE/ABSENCES:** Students are allowed no more than ten (10) excused or three (3) unexcused, unjustifiable absences during the school year.
- **TARDIES:** Students are allowed no more than five (5) unexcused, unjustifiable tardies during the school year.
- **ACADEMIC:** All work must be satisfactory or above the TK-8 level.
- **BEHAVIOR:** Interdistrict petitions for students with repeated disciplinary referrals and/or suspensions will be revoked.

**WARNING:** *Your child's continued attendance in the McCabe Union Elementary School District depends on him/her fulfilling and continuing to meet all conditions imposed herein. Prior to revocation, the District will give the parent/guardian an opportunity to explain why the conditions of continued attendance in the District were not met in order to ensure a fair and nondiscriminatory process.*
