Pandemic Electronic Benefit Transfer P-EBT



On Friday, April 24, 2020, the U.S. Department of Agriculture (USDA) approved California's application to operate a Pandemic Electronic Benefit Transfer (P-EBT) program during COVID-19.

The California Department of Social Services (CDSS) will issue P-EBT benefits to households currently receiving Supplemental Nutrition

Assistance Program (SNAP) and to households with children who are eligible for free and reduced-price school meals whose schools were closed for at least five consecutive days during the COVID-19 emergency.

Through the P-EBT program, each eligible child in the household will receive \$5.70 per day for each day of the month in which school was cancelled due to COVID-19. The California Department of Education (CDE) and CDSS estimate that this will provide more than \$1.4 billion to over 3.8 million school children throughout the state to address food insecurity during this emergency.

The CDE and CDSS have identified children from households that are directly certified to receive Free and Reduced-Price school meals. These households will automatically be mailed their P-EBT card in the coming weeks. Beginning in Mid-May, children from households who were not directly certified for free and reduced-price school meals will be able to apply online for P-EBT.

Outreach Toolkits

The CDE and CDSS will provide P-EBT outreach toolkits to school nutrition partners in the coming weeks. The P-EBT outreach toolkit includes sample communications for schools to notify eligible households about the availability of P-EBT. Schools are strongly encouraged to only use these state-provided outreach materials to reduced confusion about this new, time-limited pandemic relief program.

California Homeless Education Bills in Legislation

Two new Homeless Education bills have been introduced and are under consideration in California Legislature. AB 1937 Homeless Children and Youths and Unaccompanied Youths mandates increased identification and reporting of homeless students. AB 3218 mandates increased identification and comprehensive staff training.

Please read the bill texts so that you are familiar with the possible changes. If passed, I will let you know how these new mandates apply to your work and how we can help you fulfill the new requirements.
